



3D PRINTABLE DIGITAL FILE LICENSE

IMPORTANT: Your purchase is a license to use the digital files. Ownership of the original design is not transferred to you.

License Overview

This license applies to Honey Top Bees downloadable 3D-print files, including STL, 3MF, and other included digital formats. The rights you receive depend on the license option purchased with the product.

OPTION 1 - PERSONAL USE LICENSE

The Personal Use License is for individuals who want to print the purchased design for their own use.

YOU MAY:

- Download and store the files for your own use.
- Make backup copies of the files for yourself.
- Print the design on your own 3D printer.
- Use a third-party printing service to produce items for your personal use only.
- Print multiple copies for your own personal, household, hobby, or apiary use.
- Make reasonable adjustments to slicer settings or modify the file as necessary for your own printing needs.

YOU MAY NOT:

- Sell physical items printed from the files.
- Sell, share, give away, upload, trade, or redistribute the digital files.
- Provide the files to another person so they can print products for themselves.
- Upload the files to Thingiverse, Printables, MakerWorld, Cults3D, Etsy, Facebook groups, file-sharing services, or any other public or private distribution platform.
- Include the files in another collection, bundle, membership, course, or digital product.
- Sell or distribute modified versions of the digital files.
- Use the files for commercial manufacturing or production.
- Claim the original design as your own.

A Commercial Use License must be purchased if you intend to sell physical products produced from the design.

OPTION 2 - COMMERCIAL USE LICENSE

The Commercial Use License allows the purchaser to manufacture and sell physical products created from the purchased Honey Top Bees design, subject to the restrictions below.

YOU MAY:

- Download and store the files for use by you or your business.
- Make backup copies for your own business use.
- Print the design using printers owned or operated by you or your business.
- Sell physical 3D-printed products produced from the design through your own website, retail location, craft shows, farmers markets, eBay, Amazon, or other sales channels not specifically prohibited below.
- Sell physical printed products in commercial quantities without a per-unit royalty, unless a separate written agreement states otherwise.
- Adjust slicer settings and make reasonable modifications necessary for successful printing.

YOU MAY NOT:

- Sell, list, advertise, offer, or fulfill physical products made from the licensed design on Etsy, whether through your own shop or another seller's shop.
- Sell the original digital files.
- Share, give away, trade, upload, or redistribute the digital files.
- Sell or distribute modified versions of the digital files.
- Upload the files to any 3D-printing repository or file-sharing platform.
- Transfer your commercial license to another person or business.
- Sublicense the files to another seller or manufacturer.
- Allow another business to use your purchased files to manufacture products for its own resale.
- Include the files in another digital product, bundle, membership, course, or subscription.
- Claim ownership or authorship of the original Honey Top Bees design.

ETSY RESTRICTION: Etsy is expressly excluded from the Commercial Use License. Honey Top Bees reserves Etsy as an exclusive sales channel for products based on its licensed digital designs.

The Commercial Use License applies only to the individual or business that originally purchased the license. It grants permission to sell physical products created from the files. It does not grant permission to sell, distribute, or otherwise provide the digital files themselves.

Modified Designs

- Changing, resizing, remixing, adapting, or otherwise modifying a Honey Top Bees digital file does not remove the restrictions of this license.
- Modified digital files may not be sold, shared, uploaded, given away, or redistributed under either license.
- Commercial License holders may sell physical products printed from their modified version of the design, provided the underlying Honey Top Bees digital files remain private and the Etsy restriction is followed.

Ownership and Branding

Honey Top Bees retains all applicable ownership and intellectual property rights in the original digital design files. Purchasing a file provides a license to use the design under these terms and does not constitute a sale or transfer of the underlying intellectual property rights.

No rights to the Honey Top Bees name, logo, trademarks, product photography, marketing materials, or other branding are granted by either license.

File Security

You are responsible for taking reasonable steps to prevent unauthorized access to or distribution of the digital files. Do not send the files to friends, customers, other beekeepers, other businesses, or other 3D-printing operators except when a third-party printing service is producing an item solely for your permitted personal use.

Printing and Product Responsibility

3D printing results can vary depending on printer, filament, slicer settings, environmental conditions, and other factors. Honey Top Bees does not guarantee that every printer, material, or printing configuration will produce identical results.

The purchaser is responsible for determining appropriate materials, print settings, installation, maintenance, and suitability of any printed product for its intended application. Commercial License holders are responsible for the quality, safety, labeling, marketing, and sale of the physical products they manufacture.

License Violations

Any use of the files outside the permissions granted by the purchased license may result in termination of the license. Upon termination, permission to use the digital files ends, including permission to manufacture additional products for sale. Honey Top Bees reserves all rights not specifically granted under this license.
